Minutes of the City of Beaconsfield's regular Municipal Council meeting, held at City Hall, 303 Beaconsfield Boulevard, Beaconsfield, Québec, on Monday, November 22, 2021, at 8:00 p.m.

1. OPENING OF MEETING

His Honour the Mayor calls the meeting to order.

PUBLIC QUESTION PERIOD

His Honour the Mayor welcomes everyone to the first meeting with a new Council. He thanks the voters that have re-elected him for a third mandate and he adds that it will be a privilege and honour to serve the residents of Beaconsfield. He congratulates the members of Council that have been re-elected by acclamation: Councillors Godin, Mercuri and Newell, the re-elected Councillor Moss, Councillor Alexopoulos, elected after a pause at the last mandate, and the new elected Councillor St-Jean. He also thanks former Councillor Karen Messier for her hard work and devotion and says that she has participated in achieving the quality of life and respect for the environment enjoyed by residents of the City of Beaconsfield. He shares his disappointment in the low participating rate of eligible voters (37%) in Beaconsfield's Municipal election. He adds that to obtain a healthy democracy, the level of participation needs to be higher.

Commandant Couture provides updates and information regarding citizen's security in Beaconsfield.

His Honour the Mayor asks Councillors to say a few words at the beginning of this new mandate. They take the opportunity to thank

residents and voters and reassert their interest to work for residents and with Council for the next 4 years.

The City Clerk announces the beginning of the public question period.

A resident asks if there is a plan to link the Elm bike path between Brown Owl (EXO station) and Amherst Road (Couche Tard).

His Honour the Mayor explains that this section of the bike path falls under the responsibility of the Agglomeration of Montreal. The City has been asking the Agglomeration for several years to include this portion of their network in their work schedule. He adds that when the City receives the next schedule, we hope to find this portion of the network included and if not, the City will continue to put pressure to get this work done.

A resident asks if the WSP/MTQ report received by the City, specifies that a 6 metre long x 20 cm thick noise absorbing concrete panels be installed, like the sound barrier proposed by citizens in their March 22, 2010, petition to Beaconsfield council and the Government of Québec. He also asks, referring to Agenda item 30.2, the amount paid in 2021 to the UMQ for the renewal of the City of Beaconsfield membership compared to the 2022 cost of \$21,747.77. The resident would like to get updated information on the audit of Beaconsfield's public tendering of municipal contracts. He would like to be informed on the results/findings so far of the compliance audit conducted by the Commission Municipale du Québec (CMQ).

His Honour the Mayor indicates that he has previously explained that the City is not authorized to talk or issue any details of the content of the report. As mentioned before a public information meeting will be held in early 2022 to present the WSP/MTQ report and answer residents' questions. He confirms that the amount paid in 2021 for UMQ renewal was 21,287.24\$. As for the question regarding the audit, he adds that since the last Council meeting, there was a request for additional documents by the CMQ, which the City has complied. The CMQ has not informed us of the publication of their results and he adds that the City will gladly provide the informaton when the report is completed.

A resident indicates that his neighbour has installed a snow fence in the front yard and that as per By-law 720 these fences are prohibited. He adds that it must be removed. He explains that the neighbour had the same fence installed in the spring and was told to remove it. He asks to explain why the City does not enforce the By-laws and suggests that burlap be used to protect cedars.

His Honour the Mayor clarifies that the resident is referring to a winter protection for a hedge and not a fence. He adds that the Urban Planning Department confirms that what was installed is a protection for hedges during winter and that it is permitted and even recommended.

A resident would like to know which residents were consulted for the restructuring of the St Louis, Angel Boat Ramps. He would like information on the date of the council meeting this was voted to consult how this decision and by whom it was made.

His Honour the Mayor indicates that the Parks and Green Spaces Master Plan was subject to a public consultation in September 2017. This Master Plan serves as a guide for the City for the next 10 years and, with regards to small waterfront green spaces, it recommends rationalizing the number of water access for motorized watercrafts and to redevelop small green spaces in order to promote better access to the water for people and light watercrafts such as canoes, kayak, and paddleboard. The resolutions for the awarding of the contracts were adopted by Council on May 22, 2018, for St-Louis Park and on June 14, 2021, for Angell Park. He adds that plans were modified following comments by residents.

A resident states that if there is a referendum for the sound wall, should there not be one for the Re Imagine project that the Mayor strongly supports. She adds that the Mayor always mentions that all residents are consulted. The project is a huge multimillion dollar project that will cost

residents in increased taxes in the long run not only for the project itself but the maintenance and upkeep. She asks to explain the reason for putting a library in a beautiful park and would like to know whose idea is it. She explains that all residents should be consulted not just a small group of 150 residents, as this is 0.75% of the population of Beaconsfield which is less than 1%. She also asks to explain what will be done with the old library and indicate what is wrong with the existing Library. Finally, she asks if the Mayor will be increasing his salary in the next 4 years.

His Honour de Mayor states that the residents will have the final words since such a project would require a loan by-law, which is subject to a register. He reiterates that the project is also conditional to obtaining Federal and Provincial grants. He explains that all residents were invited to the consultations and indeed 150 residents participated. He considers this number as a high rate of participation compared to the very low turnout of most consultations and information meetings presented by the City. He adds that it was clearly identified through the consultations that there is a need for a project consisting of a multi–purpose centre. He explains that the subject of remuneration is not one that is expected to be discussed at the first caucus nor at a first Council meeting. He adds that remuneration of elected officials is decided by caucus which includes six Councillors and one Mayor. He assures that if the remuneration is discussed it will be fully analyzed before a decision is made.

A resident asks for more arenas or rinks in Beaconsfield. He refers to the new refrigerated ice rinks in Pointe-Claire.

His Honour the Major answers that the City is in the process of reviewing the budget and his suggestion is being heard tonight by Councillors of the Financial Advisory Committee members. He explains that if Council decides it is a priority, then more rinks will be considered.

A resident asks Councillor St-Jean to explain how he plans to communicate with residents of District 2. He reads an adopted resolution as a preamble to his questions concerning the management agreement for the Beaconsfield Centennial Marina between the City of Beaconsfield and Club nautique Lord Reading. He asks to obtain the estimated cost of demolishing and rebuilding certain structures at the time the agreement was signed. He also would like to know the amount spent as of today and what is the remaining cost the City expects to pay with the residents taxes. He asks information on the number of members at the Marina, the different classes of membership and the number of members that are Beaconsfield residents. He finally states that the marina site is in a park and public space zone, which means that the club and users are not taxed by the City. He asks why citizens cannot have access to the whole park and facilities which is owned by the City and built by the City like in all other parks in Beaconsfield. Finally, he asks why the citizens of Beaconsfield have to pay a second time when they want to use a boat ramp in that public park.

Councillor St-Jean indicates that there are several ways to communicate with him, by phone, email and he also mentions that he has already individual meetings scheduled. He adds that he is also planning on having online monthly meeting and will adjust according to the needs. He commits to be available to as many residents possible in District 2. Mr. Patrice Boileau, Director General, answers that the City of Beaconsfield considers that it is important to have a marina and to have an experienced partner running it. He adds that he does not have all the estimates, that Covid-19 prevented the project to move forward and that the City is revaluated as the project progresses. His Honour the Mayor answers that they do not have on hand the information on the members and will get back to the resident. Mr. Boileau says that residents can walk freely in the marina, they can also use certain ramps for light watercrafts, for no cost, but residents need to obtain a seasonal pass to use the ramps that are managed and maintained for safety by the club.

WHEREAS on November 13, 2020, the Director General commented the Draft Ministerial Order Rules to establish the fiscal potential of the related municipalities of the urban agglomeration of Montréal for the purpose of apportioning urban agglomeration expenditures, published in the Gazette



Officielle du Québec on October 14, 2020;

WHEREAS a second Ministerial Order was adopted in December 2020 by which the Minister sustained the fiscal prejudice to the citizens of Beaconsfield;

WHEREAS the Ministerial Order stipulates under Article 3, Section III, that:

"The Minister of Municipal Affairs and Housing establishes a working group composed of representatives of the City of Montréal and the Association of Suburban Municipalities in order to review the modalities of apportioning agglomeration expenditures, in particular the calculation of the fiscal potential or any other long-term solutions, and to report to the Minister by August 31, 2021";

WHEREAS the City decided to legally protect the interests of its citizens by filing an application for judicial review on January 15, 2021;

WHEREAS the parties involved in the working group established by the Minister provided no results;

WHEREAS the exchanges (August 2021) and the press release (October 2021) of the Association of Suburban Municipalities regarding the work of the committee indicate a lack of will from the City of Montréal to collaborate and to find fair and equitable long-term solutions;

WHEREAS the City of Beaconsfield, with its Municipal Council newly elected on November 7, 2021, is committed to continuing to protect the interests of its citizens;

WHEREAS all municipalities with high residential density will benefit from the proceedings undertaken by the City of Beaconsfield;

WHEREAS the deposition of the next property assessment roll by the Montréal Agglomeration in 2022 will increase the fiscal offloading of municipalities of commercial and industrial character on municipalities of residential character, thereby further compounding the unfair imbalance of the Montréal Agglomerations imbalance;

It is moved by Councillor David Newell, seconded by Councillor Martin St-Jean and UNANIMOUSLY RESOLVED:

TO deposit the report on the development of the Agglomeration quotesparts file;

TO submit this resolution in reply to the Ministerial Order currently reviewed by the Minister;

TO demand that the Minister revises her position on the Agglomeration's fiscality by considering the proposals formulated by the City of Beaconsfield in its August 2020 brief;

TO advise the Minister yet again of the interest and the availability of the City of Beaconsfield to contribute to the resolution of this issue, irrespective of the ongoing legal proceedings; and
