

Minutes of the City of Beaconsfield's regular Municipal Council meeting, held at City Hall, 303 Beaconsfield Boulevard, Beaconsfield, Québec, on November 21, 2022, at 8:00 p.m.

OPENING OF MEETING

His Honour the Mayor calls the meeting to order.

2. <u>AGENDA</u>

2.1 Adoption of the agenda of the City of Beaconsfield's regular Council meeting of November 21, 2022

2022-11-446 It is moved by Councillor Dominique Godin, seconded by Councillor Robert Mercuri and UNANIMOUSLY RESOLVED to adopt the agenda of the City of Beaconsfield's regular Council meeting of November 21, 2022, as presented.

PUBLIC QUESTION PERIOD

The City Clerk announces the beginning of the public question period.

His Honour the Mayor asks Mr. Patrice Boileau, Director General, to share the update on the offences committed in Beaconsfield which was sent by Commander Couture of the PDQ 1.

A resident refers to a Government decree concerning a sound wall being built in Pointe-Claire and the speed limit being increased from 70 km/hr to 100 km/hr on Highway 20. He asks for Council to enumerate the actions taken by the City to address the noise problem and the health issues from high-speed traffic. He also asks if the nearby residents have been consulted concerning item 20.1 on the construction of a new chalet at Beacon Hill Park. Finally, he asks questions regarding item 20.2 on the installation of temporary supports to the roofs of Centennial Hall: how "temporary" are the supports and if the City prepared plans for them.

His Honour the Mayor indicates that the City has written letters to the MTQ asking to reduce the speed limit on Highway 20. He also adds that at the public session in May with the MTQ, it was clear from them that there is no consideration of lowering the speed limit as the road has been built for a speed of 100 km/hr. He also mentions that letters were sent to the Mayors of Dorval, Pointe-Claire and Baie D'Urfé and that the three of them answered that they will not support the City's request although they would like to see more surveillance on the highway. Finally, he confirms that the reduction of the speed limit on Highway 20 will not occur. He then mentions that at the MTQ presentation on the sound barrier in May, the representatives stated that there was no evidence or information on any health issues caused by the noise on Highway 20. Thereafter, certain residents were informed through Dr. David Kaiser, Public Health & Preventive Medicine specialist, that there are health issues caused by excessive noise on Highway 20. He adds that the City wrote to the Minister of Transport and the Health Minister on June 30. He followed up with a second letter on July 26 asking the Ministers to clarify their position concerning health issues on the Highway considering Dr. Kaiser's views. He adds that the City asked to receive a clear written response from the Ministers. He specifies that health issues are under the Government responsibility which means that they would build and pay for the sound barrier. He confirms that the City did not receive a response, he believes it is due to the election. Since the election, a letter has been sent to three



Ministers on November 1: the new Minister of Transport, Geneviève Guilbault, the Health Minister, Christian Dubé as well as the Minister responsible for the Montreal region, Pierre Fitzgibbon. Once again, he asked the Ministers to clarify the position of the Government on health issues related to Highway 20 as there is a difference of opinion between them and Dr. Kaiser. He suggests being patient and that in early 2023, Council will take a decision as to what the next step should be. His Honour the Mayor specifies that the Culture and Leisure Committee, which is comprised of residents as well as associations, were consulted for the Beacon Hill Park chalet. He adds that the project was published online in 2020 in order to receive comments from all residents. Mr. Boileau explains that the City must temporarily reinforce the roofs, particularly the outdoor section over the balcony to maintain the structural capacity. He adds that the supports are temporary because the current process of exploring another project is not confirmed.

A resident indicates that she has noticed that the "pedestrian pathways" through the newly installed concrete medians in the parking lot of the Recreation Centre are difficult to access as cars park right in front of them. She adds that the lighting is quite poor in the parking area, she assumes the necessary lighting will be installed eventually.

His Honour the Mayor asks Mr. Boileau to answer. Mr. Boileau explains that the spaces in the median borders are not intended for pedestrians, but rather to ensure proper drainage. He adds that the City is currently working on resolving the lighting problem.

A resident deposits a petition concerning the 275 Elm project. Although the project is not finalized, she hopes the opinion of the residents will be considered and shares a series of preoccupations as follows: the increase in population density, the increase of traffic, the exit of this condo project on a small street (Fairway), the commercial space being created may take away parking for existing businesses, the aesthetics of the project does not fit with the character of Beaconsfield.

His Honour the Mayor invites the resident to give the petition to the Assistant City Clerk and indicates that Council has not seen any documents or plans concerning this project.

A resident asks if the criteria used to evaluate the cost to build a chalet at the Beacon Hill Park will be made public by Council in order to attest the relevance of the sum.

His Honour the Mayor indicates that every Councillor will have the chance to express themselves regarding this matter later in the meeting, he adds that the resident will be getting all his questions answered at that time.

A resident describes in a preamble that in 2017, the City presented a Parks and Green Spaces Master Plan, he indicates that the plan refers to different updates including 8 park chalets' at an estimated amount of \$550,000 each. He explains that 5 years later, the price of one chalet is 5 to 6 times more, which leads him to expect that the total amount for updating the chalets will also be 6 times higher. He asks when will the City update the numbers in the Park and green spaces Master Plan. He is concerned that the price for the City's projects will double, he would like to see the City rethink its priorities.

His Honour the Mayor reminds the resident that the cost of the chalet will be discussed later during the meeting and invites Mr. Boileau to add comments. Mr. Boileau explains that several updates have been carried out in the City's parks since the Master Plan was presented. He explains that the amount described for the chalets was to give a rough idea and that each park chalet must be evaluated to identify the needs. The City has indeed consulted the different associations and residents for the Beacon Hill chalet considering its large size and activities being conducted on a regular base. He also explains that at the present time, it is very difficult to purchase and plan for projects in the City as costs are rising.

A resident asks to repeat the answer given to explain the temporary supports to the roofs of Centennial Hall.



Mr. Boileau reiterates that the structure is not safe and needs to be reinforced. He adds that the City needs to see the outcome of the Imaging project before carrying out a long-term renovation at Centennial Hall. The temporary supports will be good for a few years which by then the City will know the outcome of the Imagine project and also know if the building needs to be renovated and upgraded to today's standards.
